PART II

Workers engaged in mixing and tempering clay, truck fillers, clay men, block carriers, workers engaged in stacking tiles on racks, workers engaged in sun drying tiles, workers engaged in helping sorters, workers engaged in helping green tile sorters, firewood carriers, pug mill feeders, workers engaged in removing baked tiles from kiln, workers engaged in stacking tile, workers engaged in moving block and clay to presses or other parts of the store, workers engaged in loading or stacking tiles in side the kiln for baking.

PARTII

Class of Workers

Class 'A' Workers:

Drivers of omnibuses licensed to carry over 22 passengers.

Class 'B' Worker:

Drivers of omnibuses licensed to carry 22 passengers and under, drivers of ambulances and drivers of lorries and vans (other than those by an estate and used solely for internal transport within the estate) with a licensed payload of over 20 cwt.

Class 'C' Worker:

Drivers of hiring cars and cabs, drivers of lorries and vans (other than those owned by an estate and used solely for internal transport within the estate) with a licensed payload of 20 cwt. and under, drivers of three wheeler and drivers of hearses.

Class 'D' Worker:

Drivers of tractors with trailers used for tansport purpose, drivers of lorries with trailers (including those of the scammel horse type but excluding those lorries with trailers or tractors owned by an estate and used solely for internal transport within the estate).

Class 'E' Worker:

Drivers of the following vehicles owned by an estate and used solely within the estate namely (a) lorries and (b) tractors with trailers.

Class 'F' Worker:

Conductors, clerks, cashiers, ticket - clerks and booking clerks employed in ominibuses.

Class 'G' Worker:

Cleaners and porters of lorries with a licensed pay load of over 20 cwt.

Class 'H' Worker:

Cleaners and porters of lorries with a licensed pay load of 20 cwt. and under, omnibuses, hiring cars, cabs, vans, ambulances and hearses.

Class 'I' Worker:

Omnibus checkers or time-keepers.

Class 'J' Worker:

Omnibus inspectors and omnibus stand supervisors.

Class 'K' Worker:

All other workers in the Motor Transport Trade excluding workers referred to in the preceding items.

In the foregoing decisions –

- (a) "Cleaners" means workers employed (other than in clerical capacities) in connection with the maintenance of the cleanliness of lorries, omnibuses, hiring cars, cabs, vans, ambulances or hearses.
- (b) "Porters" means workers employed in loading or unloading goods in to or from lorries, omnibuses, hiring cars, cabs, vans, ambulances or hearses and required to travel in the vehicles in the performance.

Semi-Skilled:

Workers preparing the ground, Caretakers of Tanks/Watchers, Lining Markers, Sealers, Makers of Cellophane Bags and Cardboard Boxes, Building Terraces and Foot-paths;

Unskilled:

Tank Cleaners, Workers preventing tanks from being soiled by various creatures, cleaners and sweepers of cold rooms,

Workers engaged in any other operations connected with or incidental to any work specified in the preceding to paragraphs.

Duties of the following workers will not be covered under this Trades.

- Workers engaged in Motor Transport Trade stipulated in the order published in Gazette No. 9481 of 02nd November 1945 will be paid and dealt according to the decision of that trade.
- Workers engaged in engineering functions will be paid and dealt according to the decision of that trade, as published in decisions of Engineering Trade Gazette No. 9224 of 07th January 1944 and amended thereafter.
- Duties of the following workers will not be covered under the decisions of this trade. Clerk, Cashiers, Time keepers, Watchers.
